In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 26 tCO<sub>2</sub>e by 2027. This is a reduction of 12%

# **Carbon Reduction Projects**

## Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented and the measures will be in effect when performing the contract.

UK based employees are home based.

Flexible/Home working & virtual meetings are embraced. This minimises emissions from a regular commute and travel only when needed.

When travelling for business purposes, rail and public transport is encouraged wherever possible.

LED lights have been installed in our offices.

Manufacturing is located in Europe with strong environmental legislation and utilising renewable energy wherever possible.

Our principal distributor has implemented driver efficiency training and driver style monitoring, which has shown a noticeable reduction in emissions, a reduction of 0.2 tonnes of C02<sup>e</sup> per million of turnover. Use of Electric vehicles is also being trialled.

In the future we hope to implement further measures such as:

Continue raising environmental awareness at all levels of our company; and encourage appropriate actions of all staff.

Orphalan do not operate company cars but instead offers a car allowance. We are investigating how we can encourage employees to adopt GHG free cars at the earliest opportunity.
